

FUNDS THAT SUPPORT CASA DORINDA TODAY

Resident Benevolent Care Fund

Established in 1988, this fund helps Casa residents who have outlived their financial resources and ensures they will always have a home at Casa. Over the years, donors have contributed more than \$1.7 million to this program.

Community Enhancement Fund – Special Purpose Gifts

Casa receives donations for special purposes throughout the year. A resident may have an experience that ties them closely to a specific department on campus, so they choose to invest in that department or area. Casa Dorinda now has its own putting green thanks to a generous gift to the Community Enhancement Fund from Dr. Albert and Toni Amorteguy.

"I thought that re-installing a putting green would benefit many of our residents. I requested that Brian guide me through the process of obtaining approval from the necessary committees. Toni and I felt that providing the funding would expedite the process. After the approval was obtained from the various levels of governance, we were able to complete the process in five days from start to finish. Being the present Chair of the Employee Emergency Fund here at Casa, and having had an independent Medical practice, I am very familiar with the emergent needs of employees as well as patients and therefore I have requested that those interested in supporting this project, please contribute to our EEF."

- Donations to the endowment are invested for the long-term strength of Casa Dorinda.
- Your original gift remains untouched in perpetuity and the earnings will be available for supporting extraordinary projects approved by the MRA Board that would significantly enrich the lives of current and/or future Casa residents.
- Once the fund reaches \$1 million, a committee will be formed to help determine how future earning will best be utilized.

Employee Emergency Fund

"I am a cancer survivor. The Employee Emergency Fund helped relieve financial stress during my recovery. I was able to come back to work slowly after I made it through my treatments. The EEF also provided assistance when my mother died. A caring resident noticed I was working all the time to save up for a plane ticket and he encouraged me to apply for this benefit. I was able to get home to my family. The EEF has come to my rescue twice and the same with other Casa employees. I've worked at other places and it is not the same feeling...here it is like a family and it's a very special place to work."
