History of Philanthropy

Casa Dorinda was established as a non-profit community in 1983 by the Montecito Retirement Association's Board of Directors. Because of Casa's tax-exempt status, and the generous giving of our residents, there have been many successful philanthropic endeavors that have significantly enhanced our campus, and the lives of our residents and staff.

- The Medical Center was built through a resident-led philanthropic effort in the 1990s.
- The Casa Scholarship Fund was established in the 1990s, and has awarded scholarships to employees and their families every year since.
- The resident-led Legacy Campaign was launched in 2016 and raised more than \$9 million. The funds were directed to Casa's new Center for Personal and Memory Care which opened in 2021.

Charitable Giving Opportunities

COMMUNITY ENHANCEMENT FUND

Contribute a restricted gift towards special equipment or specific departments, unique programming, senior care innovations, and other creative opportunities that enhance campus life.

UNRESTRICTED GIFT

Unrestricted gifts further Casa Dorinda's mission and will be directed to where the need is greatest.

ENDOWMENT FUND

The funds are invested with the principal remaining untouched. The earnings may be used for extraordinary expenditures approved by the MRA Board for Casa Dorinda facilities (buildings, grounds & equipment) that will significantly enrich the lives of current and/or future Casa Dorinda residents.

RESIDENT BENEVOLENT CARE

Provides financial assistance for residents who have outlived their financial resources, and ensures they will always have a home at Casa.

RESIDENT-DRIVEN EMPLOYEE SUPPORT FUNDS

Scholarship Fund: Provides financial assistance to Casa employees and family members who want to further their education. Average annual scholarship is \$3,500.

Employee Emergency Fund (EEF): Provides financial assistance for employees for unexpected emergencies. Employees can request up to \$5,000.

Employee Appreciation Fund: Express your gratitude to the wonderful employees of Casa Dorinda who provide exceptional care and service to residents. Contributions can be made year-round, and are distributed to non-managerial employees during the Holiday Season. *Donations to this fund are not tax-deductible.*
